At Veolia Water Technologies, Health & Safety is our number one priority, this ensures we protect our employees, sub-contractors and anyone affected by our undertakings, and this is the reason why we have an excellent track record when it comes to our Health & Safety standards.

> What does this mean for our customers?

Designing for Safety - As part of the design process, we identify and minimise any potential risks throughout the lifecycle of the plant / equipment.

Safety Sensitive Processes and Installations (SaPI)

Our Go-NO-Go Proces - Installations which fall under the SaPI criteria are required to have an additional safety review and sign off by a committee at HQ to ensure the project is safe to carry on or 'Go'.

At Point Risk Assessment - We carry out at point risk assessments prior to commencement of works to ensure that all the hazards and risks associated with the work on site have been identified and control measures put in place.

Our People - Providing the right resources at the right time. We ensure protection to execute works safely and comply with our legal duties, and constantly strive to achieve Health & Safety standards beyond those required by statute. As a minimum all our Site Managers hold an SMSTS 5 Day Site Managers Ticket, First Aid and CDM training. All of our service engineers complete the CCNSG Safety passport programme and have been trained in risk assessment, manual handling, chemical handling and working at heights, asbestos awareness, and basic electric safety, which ensures they are trained in all aspects of Health & Safety to effectively fulfil their role on site.

Sharing Experience - We have over 30 years experience of working on large construction projects throughout the UK, acting as both principal contractor, principal designer and sub-contractor, we work with all stakeholders to develop and implement best practice.

Peace of Mind - The substantial investment we make in training is evidence of the importance we place on good Health & Safety practice at Veolia.

Health & Safety pre-qualification - All our sub-contractors are subject to Health & Safety pre-qualification prior to award of a contract
